October 27	ON-TIME Registration for Continuing CCP (College Credit Plus) Student Registration Begins
October 30	ON-TIME Registration for all Continuing Health Sciences Students Registration Begins (General Prep Health Sciences Registration Begins November 6th)
November 6	ON-TIME Registration begins for All Other Continuing Students and Reactivating Students
Dec 26-Jan 1	All College offices will be closed. Bookstore will be open December 26th-29th from 9am-4pm. College offices will reopen January 2nd.
January 8	FEES due - Fees must be received in the Business Office by 5:00 p.m. or postmarked by Monday, January 8th. Students who have not paid their fees will be assessed a \$50 Late Payment Fee. For financial arrangements: contact the Business Office for payment plan options or the Financial Aid Office for possible aid opportunities. <b>Spring Semester Classes Begin (1st half and 15-week classes)</b>
Jan 8 - Jan 12	Registration for a class that has not met. Add a class that has met with Dean's Approval. Students are responsible for all tuition and fees incurred.
January 12 (By web only Jan 14)	Last day for 100% refund for 1st half and 15-week classes
January 19 (By web only Jan 21)	Last day for 50% refund for 1st half and 15-week classes
February 12	Last day to drop/withdraw for 1st half classes
February 16	Last day to make up Fall 2017 incomplete courses
March 2	Last day of regularly scheduled classes (1st half)
March 5-9	Spring Break. All College office will be open.
March 12	FEES due for students ONLY taking 2nd half classes. Fees must be received in the Business Office by 5:00 p.m. or postmarked by Monday, March 12th. Students who have not paid their fees will be assessed a \$50 Late Payment Fee. For financial arrangements: contact the Business Office for payment plan options or the Financial Aid Office for possible aid opportunities. <b>2nd half classes begin</b>
March 15	Graduation Petitions are due for Fall 2018 graduation
March 16 (By web only March 18)	Last day for 100% refund for 2nd half classes
March 23 (By web only March 25)	Last day for 50% refund for 2nd half classes
March 30	Last day to drop/withdraw for 15-week classes
April 16	Last day to drop/withdraw for 2nd half classes
April 27	Last day of regularly scheduled classes (15-week classes)
April 30 - May 4	Finals week for Spring (15-week classes)
May 4	Last day of regularly scheduled classes (2nd half)
